



Booking Terms and Conditions – Christmas 2019

A booking is confirmed on receipt of a completed booking form and required payment deposit. **A minimum of 8 guests per booking is required.**

For any bookings under 10 guests, FULL payment will be taken after provisional hold. No deposits will be due.

After ten days if the booking form and payment is not received, the provisional reservation will be released.

It is the management's responsibility to allocate seating and tables. Guests may layout name cards upon arrival at the venue, having spoken to a member of staff. Please notify us of any special requirements and we will do our best to accommodate you.

Under no circumstances will spray, party string or similar aerosol type sprays be permitted. All safety and fire regulations must be observed.

Deposit are £15.00 per person, all deposits paid are non-refundable. Any cancellations must be communicated in writing and cannot be accepted over the telephone.

Refunds will be calculated as follows: If you cancel, we will refund:

- More than 2 Months prior to the event date 100% less deposit
- More than 1 Month but less than 2 months prior to the event date 75% less deposit
- More than 14 days but less than 1 month prior to the event date 50% less deposit
- 14 days or less prior to the event date No refund

Refunds due will follow from January 2020

Goosedale will endeavor to accommodate late menu or detail changes but will not be held responsible for changes communicated less than 2 weeks before the event.

Non-payment of the final balance by the due date will render our contract with you void.

Goosedale reserves the right to refuse admission and to remove from the event any person, whose condition in the opinion of Goosedale staff, interferes, or is likely to interfere with, the enjoyment of the function by other participants.
